1. SCOPE AND PURPOSE

- 1.1 This regulation sets out the numbers of team officials and athletes which may be registered by National Federations for the following international events:
- A) World Climbing Series events.
 - B) World Climbing Championship events.
 - C) World Climbing Youth Championship events.
 - D) World Climbing Para Series events
 - E) World Climbing Para Championship events.

2. WORLD CLIMBING SERIES QUOTAS

- 2.1 Currently eligible *National Federations* may, within the published deadlines, register *Team Officials* at any World Climbing Series event in the capacity and number set out in Table 1 (*Team Officials*)
- 2.2 In disciplines where athletes compete as individuals, currently eligible *National Federations* may, within the published deadlines, register for each gender category and discipline of the relevant World Series event as follow:
- A) up to two (2) currently-eligible competitors;
 - B) in addition to the individuals covered above, up to an additional four (4) competitors where the *National Federation* is the host nation; and
 - C) an additional number of competitors where the *National Federation* has an *Additional Quota* in a relevant gender category and discipline, up to the number of that *Additional Quota*. The *Additional Quota* will be determined by the number of competitors ranked between 1st and 40th in the relevant World Ranking as at the end of the previous year using the values set out in Table 2 (Additional Quota)
- 2.3 In the Speed-Relay discipline, currently eligible *National Federations* may, within the published deadlines, register for each gender category of the relevant World Climbing Series event as follow:
- A) up to two (2) teams of currently-eligible competitors;
- 2.4 World Climbing will publish annually the calculated *Additional Quota* in each gender category and discipline for each relevant *National Federation* not later than 31 January each year. Any subsequent additions/deletions from this list will require the approval of the World Climbing Executive Board and will be published on the World Climbing website and communicated directly to all *National Federations*.

3. WORLD CLIMBING CHAMPIONSHIP QUOTAS

- 3.1 Currently eligible National Federations may, within the published deadlines, register *Team Officials* at the *World Climbing Championship* in the capacity and number set out in Table 3 (*Team Officials*)
- 3.2 In disciplines where athletes compete as individuals, currently eligible National Federations may, within the published deadlines, register for each gender category and discipline of the *World Climbing Championship* as follow:
- A) Up to two (2) currently-eligible competitors;
 - B) Any current World Champion, in the Discipline for which they are champion;
 - C) Continental Champion from the preceding season (even-numbered years), if any, in the Discipline for which they are champion;
 - D) an additional number of competitors where the National Federation has an Additional Quota in a relevant gender category and discipline, up to the number of that Additional Quota. The Additional Quota will be determined by the number of competitors ranked between 1st and 40th in the relevant World Ranking as at the end of the previous year using the values set out in Table 2 (Additional Quota)
- 3.3 Where events in the Speed-Relay discipline have been approved for inclusion, currently eligible *National Federations* may, within the published deadlines, register for each gender category included as follow:
- A) up to one (1) team of currently-eligible competitors;
- 3.4 For the avoidance of doubts, the Additional quotas that will be granted at the *World Climbing Championship* will be always fixed to forty (40), respecting the maximum number of quotas per National Federation. If any National Federation will reach the maximum number of additional quotas (as set out in Table 4), the remaining quotas will be allocated to the following ranked athletes (i.e. 41st rank, 42nd rank, etc.).
- 3.5 World Climbing will publish annually the calculated Additional Quota in each gender category and discipline for each relevant National Federation not later than 31 January each year. Any subsequent additions/deletions from this list will require the approval of the World Climbing Executive Board and will be published on the World Climbing website and communicated directly to all National Federations.

4. WORLD CLIMBING YOUTH CHAMPIONSHIP QUOTAS

- 4.1 Currently eligible National Federations may, within the published deadlines, register *Team Officials* at *World Climbing Youth Championship* in the capacity and number set out in Table 5 (*Team Officials*)
- 4.2 Currently eligible National Federations may, within the published deadlines, register for each gender, age category and discipline of the *World Climbing Youth Championship* up to three (3) currently-eligible competitors;

5. WORLD CLIMBING PARA SERIES & CHAMPIONSHIP

- 5.1 Currently eligible National Federations may, within the published deadlines, register *Team Officials* at *World Climbing Para Series* events in the capacity and number set out in Table 6 (*Team Officials*).
- 5.2 Currently eligible National Federations may, within the published deadlines, register for each gender, age category, sport class and discipline of the *World Climbing Para Series* up to five (5) currently-eligible competitors.
