**Introduction to the revised structure of the 23<sup>rd</sup> World Climbing General Assembly**

In light of the current crisis in West Asia, and following careful consideration by the Executive Board, the format of the 23<sup>rd</sup> World Climbing General Assembly has been revised.

The General Assembly will now be held virtually on **Thursday 23 April 2026 from 12:00 to 15:00 CEST** and will be limited to those items that require formal validation by the General Assembly under the Statutes. The agenda has therefore been streamlined to focus on essential statutory and decision-making matters, ensuring institutional continuity and alignment with legal obligations.

Non-statutory discussions and in-depth thematic sessions initially foreseen within the General Assembly framework will be deferred to the Climbing Summit later in the year, and/or to other dedicated in-person meetings, as appropriate. This approach will allow for meaningful and properly structured dialogue at a time and in a format conducive to engagement, while ensuring that World Climbing's governance and operational activities continue without disruption.

The Executive Board remains committed to maintaining transparency and continuity of the organisation's work and will provide further information regarding the adapted agenda and subsequent consultation opportunities in due course.
