APPENDIX

Athletes Cancellation Policy

1. Introduction

The number of athletes attending the IFSC sanctioned events is a key information to manage the running of the competition professionally. The event preparation starts weeks before the event date, and it is based on the number of competitors. For this reason, Member Federations are required to comply with the registration deadline as set in the Rules. However, it has been observed that the number of registered athletes to the competition is often significantly higher than the number of attending competitors. To limit such circumstances, an extra fee for repeated athletes' no-show is introduced from 2023 on.

2. Policy

National Federation registered athletes = X

National Federation competing athletes = Y

Where:

Registered athletes (X) are the athletes that are registered on the IFSC result system at the registration deadline

Competing athletes (Y) are the athletes that obtain a result on the same competition

When:

X is higher than Y

Then:

The Federation will receive an extra invoice at the end of the season based on the difference between X and Y, with a tolerance of 10%. The amount of the cancellation fee/athlete is the same of the registration fee set in the IFSC Fee System for that specific event.
